# NSW Secondary Principals' Council Sustainability Position Paper

#### **Preamble**

The NSW Secondary Principals' Council has a moral and ethical imperative to ensure that the NSW Department of Education adopts and embeds system-wide sustainable practices and quality sustainability educational outcomes.

1. Recommendation Area 1.
